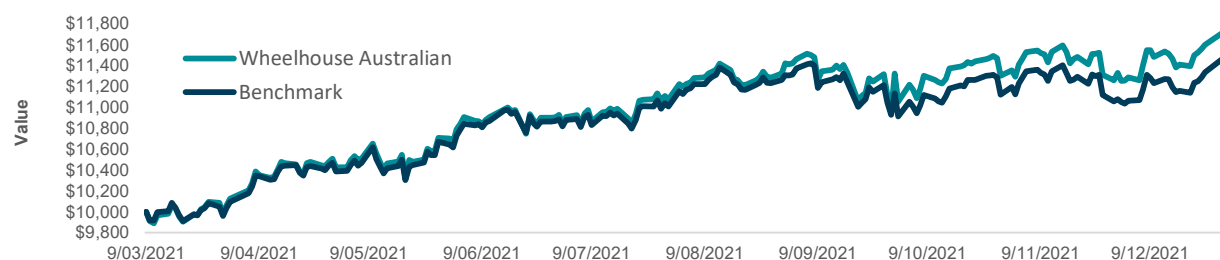

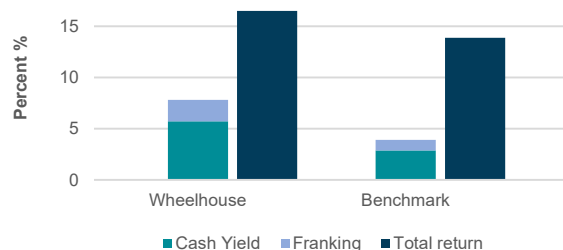
### Cumulative Returns - Growth of \$10,000
